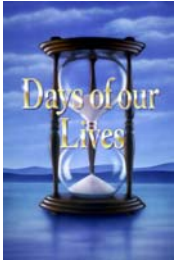

I do hereby declare that I am: a permanent legal resident of one of the 50 states of the United States or D.C.; 18 years of age or older or the age of majority in the jurisdiction where I reside as of November 13, 2009 (The age of majority is nineteen (19) years of age in Alabama and Nebraska, twenty-one (21) years of age in Mississippi, and eighteen (18) years of age in the remaining 47 states and the D.C.); and have a valid Social Security number or a valid U.S. personal tax identification number .

I further represent that I am not an employee of, a member of the immediate family of, and/or a person living in the same household as such persons (whether related or not) of Corday Productions, Inc. (“CPT”), NBC Television Network (“NBC”), MGM Grand Detroit, Gleaners Community Food Banks of Southeastern Michigan, Boost Mobile, the show “Days of our Lives” (“Show”), participating television and radio stations, and each of their respective advertising publicity, or promotion agencies, those involved in the production, development, implementation or handling of this Contest, any agents acting for, or on behalf of the above entities, their respective parent companies, officers, directors, subsidiaries, affiliates, service providers, any other person or entity associated with the Contest (collectively, “Contest Entities”).

I understand and agree that:

The photo submitted by me must: (1) not contain anyone else except for me; (2) be wholly original, previously unpublished and my sole property and if the photo was taken by some other person, I warrant and represent that I have obtained all rights and permission from such person so that I own all right, title and interest in all aspects of the photo; and (3) not contain any elements that would give or threaten to give rise to criminal or civil liability or that encourages conduct that constitutes a criminal offense, or encourages or provides instructional information about illegal activities;
- I must not have any of the following agreements in place (written or oral) at the time of entry: (1) An agreement relating to the use of my name, voice, and/or likeness; (2) an exclusive acting contract; and/or (3) any other contractual arrangement that, in the Show's producers' sole discretion, would prohibit me from fully participating in the Show;

- If selected as a Finalist or the winner, I will complete any additional documentation designated by Sponsor at its sole discretion; and
- If selected as the winner, I am able to travel to Hollywood, CA as described as part of the prize.

If I am a member of an actor's organization/union, I am in good standing with said organization/union.

I irrevocably grant Contest Entities, their successors and assigns, a non-exclusive license (but not the obligation) to reproduce, publicly perform, stream, exploit and otherwise use any videotape or other recording of me, the photo or any of the information provided in the documents I submit for participation in this Contest throughout the universe, in perpetuity, by means of any and all media and devices whether now known or hereafter devised.

I understand that my presence at the Event Location and the presence of any of my friends, family members, and anyone else accompanying me, constitutes my own and each person's consent and agreement to the recording of their appearance, name, voice, likeness, and/or performance for use in connection with any television program, motion picture, or the internet for all purposes (including advertising, marketing, promotion, merchandising, and the exploitation of any and all ancillary and subsidiary rights), as the same may be edited, in all media now known or hereafter created, throughout the universe, in perpetuity, for no compensation. Furthermore, I irrevocably grant the Contest Entities and their respective successors, assigns and licensees, the right to use my name, likeness, biographical information and photo, and individual(s) participating therein, in any and all media for any purpose, including without limitation, advertising and promotional purposes as well as in, on or in connection with the Show, the Web Site or the Contest or other promotions, and I hereby release the Contest Entities from any liability with respect thereto.
